The U.S. Bankruptcy Court in Knoxville, TN is requesting quotes for the following work to be done in the Howard H. Baker Jr. U.S. Courthouse.

The work shall include painting, patching/repair of drywall where needed, fill nail holes, and sand any drywall or chair rail imperfections. Walls, doors, and trim shall be painted with two coats of paint, matching the existing paint color and texture. The courthouse has a mixture of eggshell, flat and satin enamel paints.

Extra care should be taken to cover all furniture, benches, floors, and millwork. The contractor will be required to move furniture and return it to its original location, as needed. The Court will remove any printers, PCs or copiers prior to the work being done.

All areas should be cleaned daily with a detailed cleaning at the end of the job. The quote should include labor, materials, fees, and the estimated amount of time necessary to complete the work. Parking is not provided at the courthouse. The actual work will need to be scheduled in advance with the Bankruptcy Court and should begin within 75 days of receipt of order.

The U.S. Bankruptcy Court intends to make an award based on the lowest priced, technically acceptable quote. All items should be quoted as a fixed price award. - 1. Courtrooms 1B and 1C: work to only be done on the back wall of each courtroom and will include patch/repair and painting above the millwork, corner to corner.
- 2. Wall Space Vestibules, Witness Rooms, Robing Room Courtroom 1B & 1C

Painting of wall space to include public vestibules leading into Courtrooms 1B & 1C; witness conference rooms to the left and right side of Courtroom 1B; one witness conference room of 1C; Judge's robing room, kitchenette, and secured hallway of 1C.

3. Painting of Soffit / Ceiling Spaces

Painting of the drywall soffit/ceiling at the vestibules of Courtrooms 1B & 1C and in the robing room (tape seam in robing room in one area). Repair drywall imperfections on soffit/ceiling where needed.

4. Trim work, as specified:

Chair rail and baseboard in vestibules of Courtrooms 1B & 1C. Includes painted door and frame in 1C and 1B.

Witness conference rooms (2) for 1B – crown, chair rail, baseboard, doors, and frames.

Witness conference room for 1C – crown, baseboard, chair rail, door, and frame.

Secure hallway of 1C – includes crown, chair rail, baseboard, 2 doors and frames (excludes door to private bathroom).

Robing Room and kitchenette – crown, chair rail, baseboard, door, and frame.
